- Mr. Rullo motioned to accept the resignation of Full time Police Officer Brandon Morris effective July 15, 2022. Seconded by Mrs. Petrosky. Motion carried unanimously.

# **Streets – George Toth**

- Mr. Toth noted line painting around the Borough has been put on hold due to a shortage of street paint. We have tried several outlets and it is not available. Jim Comunale has the paint on order.
- Mr. Toth announced the Borough currently has about 200 tons of rock salt on hand and the Public Works crew uses close to 100 ton per salting. This information was asked for at the last meeting.

# Parks and Recreation - Debora Freeman

- Ms. Freeman stated the Borough purchased pickle ball nets and the Public Works Crew has painted pickle ball courts at Summers Field and the playground at the water tower playground. We have a net for Sugar Camp as well.
- Ms. Freeman opened the meeting to discussion of Baseball Field. Mr. Toth suggested buying some field dry and a few tons of infield dirt for next year. Nick Turner mentioned that there is one team that plays on the field. Mr. Bolen was directed to obtain the cost of field dry and infield dirt.
