Mr. Rullo motioned to approve Minutes from the February 14, 2022 Borough Council Combined Meeting. Seconded by Mr. Toth; Motion carried unanimously.

Mr. Rullo announced the following Executive Sessions:

Citizen Comment.

Mr. Thomas Dick, Sr. cited complaints about kids playing on Agatha Street He stated the playground is locked and the kids play in the parking lot. They throw rocks and damage vehicles. Mr. Dick requested a street camera be placed on Agatha. Asked if the Pitcairn Police could get access to Propel School Cameras. Jim Comunale stated he could put a camera there but it will cost the Borough. Mr. Comunale stated that if you see the kids on camera will you be able to identify them, would you know who they are? Chief Farally stated he will try to step up patrols.

Mrs. Petrosky asked Mr. Comunale to provide a summary of what was going on with Summers Field. Mr. Comunale stated that a lateral sewer line that serves three houses on Highland became clogged. The Borough along with Urban construction dug about 30-40 feet without being able to find the pipe connection. The sewer line is very deep because at one point Summers Field was a hillside. A contractor was brought in and dug up to 70 feet deep with out being able to reach it. It was decided with the advice of the engineer to put in a new line and run the sewer line for the three homes over the hill and into the main line via a manhole cover. Mr. Comunale stated that EADS, Borough Engineers are applying for a grant that will hopefully pay for a permanent fix. Discussion took place on how to repair Summers Field.

Mr. Kevin Dick thanked the Borough for all of its work and hoped that his yard and driveway can be repaired.

Jim Comunale provided that Duquesne Light has installed two new Intelliruptor switches' and when the new lines are repaired, power outages should be reduced to a minimum. Mr. Comunale stated that his opinion is to not do the two intellirupters in our system. He stated that Duquesne Light is one of the most reliable electric companies.

Personnel / General – Megan Law

Mrs. Law made a motion to accept Annette Dietz's letter of resignation as Borough Manager effective February 28, 2022. Seconded by Mr. Roberta. Motion carried unanimously.

Mrs. Law made a motion to appoint Michael Bolen as interim Borough Manager and Borough Secretary with a 17% stipend. Seconded by Mr. Toth; Motion carried unanimously.

Mrs. Law made a motion to change the time of the Borough of Pitcairn Meetings to 7:00 PM on the second Monday of the month. Seconded by Mrs. Petrosky; Motion carried unanimously.

Streets - George Toth

Mr. Toth announced the 2012 Ford pick-up truck sold on Municibid for \$13,600 and a salt spreader sold for \$865.

Mr. Toth announced PennDot will be replacing several handicap ramps on Broadway this Spring as part of their 2021 paving project.

Mr. Toth announced that this Spring WPJWA will be replacing various residential lead lines within the borough at no cost to the homeowners.

Mr. Toth also wanted to thank the street crew for all of their work through the last snow storm.

Parks and Recreation – Domenic Roberta

Mr. Roberta made a motion to grant permission for field and concession stand use to the following applicants: Dirty Dawgs Softball Team Every Friday beginning May 1 through August 31, 2022. Mr. Dick, Jr. stated that as long as they know they cannot use during the Fireman's Fair. Mr. Bolen stated that the application stipulates the approval is subject to schedule conflicts. Mr. Dick, Jr. stated that the team usually takes that week off. Motion was seconded by Mrs. Petrosky; motion carried unanimously.

Mr. Roberta reminded everyone that the Easter Egg Hunt will be held on Saturday, April, 16 at 11:00 AM.

Mr. Roberta made a motion to approve the continued use of the Park Building by the Department of Agriculture at \$400 per month. Contract April 1, 2022 to September 30, 2022. Mrs. Law asked if this granted them use of the entire park building. Mr. Bolen explained that they only use the small office to the left of the entrance and it is only during normal business hours. Motion was seconded by Mrs. Petrosky; Motion carried unanimously.

Mr. Roberta stated that April 29 is Pitcairn's second Night Market, times are 6 pm to 9 pm. He urged all to attend

Discussion was held about Summers Field repairs and possible grant applications that EADS could apply for. Mr. Kevin Dick stated that previous Council discussed using American Recovery funds to make

Finance and Economic Development – Lisa Petrosky

Mrs. Petrosky made a motion to pay bills as presented. Seconded by Mr. Roberta; Motion carried unanimously.

Mrs. Petrosky asked that all watch for the opening this Spring of Dosa Cupcakes on Broadway, possibly March 21.

Health and Welfare –Richard Tartaglione

Nick Turner, Code Enforcement Officer, submitted his monthly reports to Council. Mr. Turner stated that Peoples Gas has completed their work and should start repairing streets and sidewalks.

Clean up day is set for April 23, 2022. There will be one dumpster at 582 Sixth and 2 behind the ballfields. As well as our dump trucks for tires and a dumpster for scrap metal.

Mr. Tartaglione made a motion to use Sewer Capital funds to pay for the Highland Ave Sewer Emergency. Seconded by Mr. Roberta; Motion carried unanimously.

Mr. Tartaglione made a motion to approve Code Enforcement Officer, Nick Turner, to attend the PA Construction Code Academy Mechanical Code Essentials Class on March 22 & 23. The class is virtual. He would take it at the Borough Building. Seconded by Mr. Toth; Motion carried unanimously

Mr. Tartaglione made a motion to adopt Resolution 8-2022 request a Statewide Local Share Assessment grant of \$_697,830.00 _ from the Commonwealth Financing Authority to be used for Borough of Pitcairn - Sanitary Sewer Repairs _ . Deadline for the application is 3-15-22. Grant to be submitted by EADS. Seconded by Mr. Toth; Motion carried unanimously.

Don Black stated that the manhole was not up to grade. The sewer Pipe is not in good condition, there are a couple streets that tie in to couple streets tie in to the system.

Electric – Tom Dick, Jr.

Mr. Dick stated that electric was pretty much covered in the citizen comments.

An electric outage occurred on 12^{th Street}. Jim Comunale wasn't contacted through the normal channels. It was out for several hours. Chief has sent a memo to dispatch so everything is corrected.

The 1992 Ford F700 bucket truck sold Municibid for \$8,850.00.

Public Safety - Jim Rullo

Mr. Rullo stated Pitcairn has been awarded a grant in the amount of \$42,000 to purchase a new police vehicle. Which was picked up on February 28. Documents have been submitted and we should have the funds in about 6 weeks.

Mr. Rullo motioned to accept the resignation of Officer Falleroni. Seconded by Mr. Roberta; Motion carried unanimously.
