Preliminary budget presented by Manager to Council and Mayor.

Tom Dick, Jr. motioned to approve the Minutes from the October 9, 2023 Borough Council Combined Meeting. Seconded by Deb Marto. All ayes, motion carries.

Jim Rullo announced that an Executive Session was held on October 26, 2023 to discuss a public safety matter.

Citizen Comment.

VA Crothers questioned 516-518 Brinton Ave burning trash. She asked Chief about the stop sign in Rock Alley. Chief Farally stated that when he was there the fire was not very big, and they are allowed to have a recreational fire. He also stated there is no stop sign in Rock Alley. The Chief asked that Ms. Crothers call the police if they have any issues.

Mr. Pizzuto also asked about expanding the club to increase the size of the back room. He was directed to speak with our code enforcement officer. The Engineer stated that since the Borough owns the streets, a study is not necessary. George Toth motioned to add the stop sign at the corner of Sixth Street extension and Ninth Street. Seconded by Tom Dick, Jr. All ayes, motion carries.

- George Toth motioned to approve Resolution 15-2023 requesting a Statewide Local Share Assessment grant of \$390,561.00 from the Commonwealth Financing Authority to be used for Borough of Pitcairn Merchants Alley Paving Project. Lisa Petrosky asked if there was a Borough match. The Engineer stated there was not. Seconded by Tom Dick, Jr. All ayes, motion carries.
- George Toth motioned to approve Resolution 16-2023 requesting a Statewide Local Share Assessment grant of \$708,378.00 from the Commonwealth Financing Authority to be used for Borough of Pitcairn Brinton Avenue Roadway Reconstruction. Seconded by Tom Dick, Jr. All ayes, motion carries.

Parks and Recreation - Debra Freeman

- Harvest festival report, 60 kids attended, not all the parents walked the parade even though they were encouraged to walk with their child. Each child received a prize as well as candy.
- Old Fashion Christmas will be held on December 16 at the Park Building at 6:00 PM, Toys will be handed out and the children can get their picture taken with Santa. There will be a hayride and a bonfire.

- A discussion of the Garbage contract took place. The Manager explained that we did not receive any bids for the advertised garbage contract. The Contract with Waste Management expires on December 31, 2023. The manager reached out to Swissvale Borough to see how they started collecting their own trash. Swissvale Borough Manager offered to collect Pitcairn's trash for the same cost as Waste Management. Tom Dick, Jr. motioned to enter into an agreement with the Borough of Swissvale for trash pickup. Seconded by George Toth. All ayes, motion carries.

Ms. Marto announced that Protect PT will hold a meeting to discuss the Monroeville landfill at Fire Company #1. She encouraged all to attend.

Lisa Petrosky announced that Protect PT will provide air quality monitors. They will monitor and read the monitors and provide the data.
