Tom Dick, Jr. announced that there was an Executive session held at 5:30 PM.

Jim Rullo motioned to approve the minutes for the Council Meeting held on April 8, 2024. Seconded by George Toth. All ayes, motion carries.

Deb Marto motioned to amend the agenda to include the mayor asking for a temporary handicap parking spot at 714 Sixth Street. Seconded by Lisa Petrosky. All ayes, motion carries.

Citizen Comment

Anthony Pizzuto of the Italian Club asked if the Borough could look at the curb in front of the Italian Club. The curb is crumbling. Mr. Pizzuto also asked if the Italian club could use the field at Summers Field to park cars on Saturday, May 18, 2024, during a fund raiser they are having. It was asked how many cars? Mr Pizzuto stated they have looked at a couple of spots, 582 Sixth isn't available. There are a limited number of spots on the street. They will try to utilize other spots. The solicitor stated that if Council is agreeable then he could draw up a simple hold harmless clause for both parties to sign. They will try to keep cars away from the hill. Tape off a section where the cars will park.

At this time a motion was made by Lisa Petrosky to allow the Pitcairn Italian Club to use Summers Field pending the execution of a hold harmless agreement. Seconded by Deb Marto. All ayes, motion carries.

Nick Turner stated that the Monroeville fire company has offered a red trailer to the Pitcairn Fire Company for training. The trailer is basically a maze for the firefighters to crawl through, simulating a burning house. red trailer is a maze to train firefighters. Questions were raised when he needed an answer and where would the trailer be stored. Monroeville needed an answer by Monday May 13, 2024. The trailer would be stored next to the fire company at 100 South Center Ave. The council stated that it could be an eyesore and they were trying to beautify the area near the Fire Company. The trailer is currently located in a lot in Trafford. The council will go look.

Kevin Dick asked how many tickets are written, he stated that information should be on the agenda. The manager explained the tickets written would be read aloud. Mr. Dick asked what was going on with the case against 368 Broadway, the solicitor stated that it was still in litigation, and we could not comment on it. Mr. Dick asked about the Landlord tenant registration. The solicitor stated that the study was done, and we will advertise and amend the ordinance at the next meeting. He then asked if anything was being done about the alleys, that there was a sink hole in the 500 block of Merchants alley. The manager stated that the Borough has applied for a grant to rebuild Merchants alley from Wall Avenue to Brinton Avenue. Mr. Dick asked about the trash in the alleys. A discussion took place.

Parks and Recreation – Lisa Petrosky

- Lisa Petrosky motioned to waive the fee and allow the Pitcairn Presbyterian Church to use the Cliff Adams field on August 10, for a Kick, Pass and Punt contest. Seconded by George Toth. All ayes, motion carries.
- A discussion took place regarding a Holiday Decoration Contest in December. Ms. Petrosky thought
