Mayor Betsy Stevick

The mayor announced the police responded to 304 calls for the month of August. The Borough collected \$200.00 in parking fines, \$150.00 in magistrate fines, \$323.00 in County fines and collected \$75.00 in Quality-of-Life fines.

The mayor explained Noble Environmental's process for collecting electronics. They will have a collection at Monroeville Public Works on October 12, 2024. The Halloween parade is October 26 at noon. The parade begins at the Assembly of God church on Wall Avenue.

Personnel / General – Domenic Roberta

- Domenic Roberta motioned to pass Resolution 19-2024 Slums and Blight Resolution for Act 152 Grant Application for the demolition of 214 Highland and 400 Second Street. Seconded by Deb Marto. Bill Kornrumph asked if there was a plan for after tearing the buildings. He explained that he rode past 214 Highland and said it is a structurally sound building. He asked if the Borough has tried to find a buyer. Mr. Bolen stated that the Borough has contacted several churches and developers have looked at it but no one seems to be interested in the building. Motion of the floor was Three ayes and one nay. Motion carries.
- Domenic Roberta motioned to pass the Act 152 Concurring Resolution 20-2024. Seconded by Deb Marto. Three ayes and one nay. Motion carries.

Parks and Recreation - Lisa Petrosky

Lisa Petrosky gave a Night Market Reminder. Market is Friday September 27 at 6:00 PM. We will have some new food trucks, Hibachi Lou and a Gyro truck. Pitcairn's own Denny Price will have his BBQ stand at the market.

Finance and Economic Development – Bill Kornrumph

- Bill Kornrumph motioned to pay bills as presented. Seconded by Lisa Petrosky. Bill Kornrump explained that because of the payments for Tenant Registration refunds he will abstain from voting. Three ayes, one abstention. Motion carries.
- Bill Kornrumph motioned to advertise the 2025 Budget Meetings: Times of the meetings were openly discussed and 5:30 PM was decided to be the best time. Meetings will be Monday, October 14th, Monday, November 11th at 5:30 PM to be followed by regular Council Meetings, final Budget Meeting Monday, November 18th at 6:00 pm. Budget to be advertised for adoption on December 9th at 6:00 pm. All ayes, motion carries.
- Bill Kornrumph motioned to adopt Resolution 14-2024 approving the 2024 MMO's (Minimum Municipal Obligation) as calculated by the actuary: \$78,284 for the Police Pension and \$51,868 for the Non-Uniform Pension. Seconded by Deb Marto. All ayes, motion carries.

Health and Welfare – Deb Marto

- Deb Marto announced that Mr. Turner has submitted his monthly reports to the Council. HE issued 21 violations for high grass and six for trash or rubbish accumulation.
- Deb Marto motioned to accept the bid of Neumeyer Environmental Services in the amount of \$39,700 for the removal of the tanks at 121 Wall Avenue. This is to be paid with the remaining grant funds from the demo grant received through Senator Brewsters Office. Seconded by Lisa Petrosky. All ayes, motion carries.
- Information on in-house garbage collection was presented by the Borough Manager.. Discussion followed. The Borough Manager explained that he sat down with the manager from Swissvale and went over some costs. All in it would cost approximately \$383,651 in expenses and the borough roughly takes in \$275,000 in revenue for trash collection. The Borough would need to raise rates significantly to make it feasible.

The third year calls for the full monthly charge of over \$11,000 per month in transmission enhancements.
